
NOTICE IS HEREBY GIVEN that the Public Works Department of the City of South San Francisco, San Mateo County, California, pursuant its Open Trench Notification Process, is accepting Notices of Intent to Participate from Telecommunications Service Providers for collocating telecommunication facilities in the public right-of-way as part of the MCI Metro Project #: 073743-002_SOUTH_SAN_FRANCISCO_021 located on the following Public Streets:

700 Gateway Boulevard from Oyster Point Boulevard to Gateway Boulevard

Description of Work:

Project is for placement of (1) handhole, 1,091 of directional bore, 30 LF of open cut trench, and a total of 1,121 underground fiber and conduit.

In order to participate in the above referenced project, Telecommunications Service Providers must submit the attached Notice of Intent to Participate by (10:00am on Friday, July 12, 2019) at the office of the City of South San Francisco Engineering Division at the City Hall Annex, 315 Maple Avenue, South San Francisco, California, 94080.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of <u>MCI Metro</u> and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that <u>MCI Metro</u> is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.
