City of South San Francisco ("City") Hauling Permits are issued in accordance with Title 13 of the South San Francisco Municipal Code. Permittees and their agents are granted permission to haul earth over Public streets subject to these Standard Conditions and any additional Special Conditions. Permittees agree that any work performed under this Hauling Permit constitutes acceptance of the Standard Conditions and Special Conditions of this permit.

Standard Conditions

1 Permit Availability: A copy of this hauling permit shall be kept on-site and/or on the hauling vehicle at all times.

- 2 Work Hours:
- No excavation or hauling allowed before 8:00AM or after 6:00PM.
 - No excavation or hauling allowed on weekends or holidays.

- 3 Methods:
- The hauling contractor shall either cover the earth hauling trucks or thoroughly sprinkle the earth material so that no dust is blown off the trucks during transit.
 - No hauling trucks shall be overloaded.
 - All hauling trucks shall conform to State highway standards.
 - Earth hauling vehicles shall be confined to the haul route approved by this permit and to official truck routes previously adopted by City Council.

4 Cleanliness: Public streets and private driveways shall be cleaned, swept, and/or flushed each day to the satisfaction of the City Engineer or their designee immediately after ceasing hauling operations. The hauling route will be inspected by the Public Works Inspector. Permittee shall cleanup any spilled material or debris immediately.

5 Bond/Deposit: A \$2,000 refundable deposit shall be paid to the City prior to permit issuance. This deposit will be refunded after hauling activities are complete, and the Public Works Inspector has confirmed the hauling route is clean and free from spills.

6 Permit Fee: A non-refundable Hauling Permit fee based on the most recent master fee schedule shall be paid to the City prior to permit issuance.

7 Exclusivity: This Hauling Permit is only applicable to the scope and work authorized in the application. A separate Hauling Permit is required for each hauling project.
