SUMMARY OF CRIME INCIDENT (If no arrest, include suspect info.) Information need not be released that: (1) would endanger the safety of a witness or other person; (2) would hamper successful completion of the investigation or related investigation; (3) is an analysis or conclusion of the investigating officer. The name and address of a victim of any crime defined by Section 261, 264, 264.1, 273a, 273d, 273.5, 286, 288, 288a, 289, 422.6, 422.7, 422.75, or 646.9 of the Penal Code may be withheld at the victim's request or at the request of the victim's parent or guardian if the victim is a minor.

On Friday evening at approximately 6:26 p.m. a South San Francisco resident was sitting in her car on the 400 block of C Street in South San Francisco, when a subject started knocking on the window and shaking the car. When the victim opened the door, the suspect assaulted her, stole her personal property and fled in an older model red van. The victim did not sustain any injuries from the assault.

Approximately 15 minutes after the incident, a resident reported a suspicious red van on the 100 block of B Street, a few blocks away from the original incident. Responding officers located San Mateo resident Rosa Vargas standing near the vehicle in possession of the victim's property. The victim positively identified Vargas as the suspect who stole her property. Vargas was later booked into the San Mateo County main jail without further incident.
