On 11/05/2018 at approximately 7:49 A.M., a shooting occurred on the 2200 block of Gellert Boulevard. Two suspects, who were identified as South San Francisco residents, Jose Luis Hernandez and Aron Hernandez, accosted the victim while he was stopped in his vehicle on Gellert Boulevard. One of the suspects, exited their vehicle and fired an unknown weapon into the vehicle. The victim, who was an acquaintance of the suspects, escaped unharmed. The suspects fled the scene and were apprehended a short time later by South San Francisco Police Officers. This is an isolated incident and there are no outstanding suspects or further public safety threat.
